It is understood that A-B's production equip and rights to technology of the dropped lines are on the block, and that a number of companies are interested in buying them. An A-B source described the phase-out as effective immediately.

EMP THREAT TO POWER INDUSTRY- The Defense Civil Preparedness Agency (formerly the Office of Civil Defense) recently emphasised the EMP threat to our electric power network. "For more than a decade, one of the basic planning assumptions was that electric power to consumers would continue, except where power generators or distribution lines become inoperable by the direct effects (blast, heat, fire) of nuclear explosions.

New knowledge of nuclear explosion effects have made that assumption no longer valid. When a nuclear weapon explodes very hi above the ground, great quantities of gamma rays are generated and spread very rapidly in all directions. The rays traveling downward strike molecules of air, and knock the electrons out of the atoms that make up the air molecules. These electrons in motion constitute a large current source, which radiates an EM field, similar to that produced by lightning, but stronger. This phenomenon is called an EMP. If it strikes a conductor the pulse can cause a powerful electric current to be set up in the conductor. If the conductor happens to be a power line, the current could burn out the sensitive power control equip. These large currents could also cause damage to electrical or electronic equip in homes, offices, industrial plants, computer facilities, and other places using electric power.
